Drug Arrests

First Aid Calls

PESS Matters

15 incidents handled by Patrol Division personnel during the month of **August 2013** involved the use of the Psychological Emergency Screening Service (PESS) and possible custody and commitment.

Investigative Division

The **Investigative Division** activities for the month of **August 2013** are as follows:

Case Management

30 cases were assigned during the month of **August** and currently 7 of the 30 remain open.

7 cases were closed from previous months.

Off-hour Duty Calls

4 incidents required a detective to respond in during off hours during the month of **August**.

Grand Jury Court Appearances

10 cases required the appearance of a detective at Grand Jury during the month of **August**.

Prescription Drop Box

The Prescription Drop Box was emptied on 5 occasions totally 114 pounds and 0 trips were made to deliver the items during the month of **August**.

Background Investigations

Firearms - 21 firearms background investigations/permits were processed during the month of **August**.

Employment - 0 background investigations were conducted during the month of **August**.

Volunteer Fire/First Aid - 2 volunteer background investigations were processed during the month of **August**.
